



# Message from the Board President

The Ohio Revised Code (state law) 4761.03 describes the duties of the Ohio Respiratory Care Board. Among those it states: “The Ohio respiratory care board shall regulate the practice of respiratory care in this state and the persons to whom the board issues licenses...” The law empowers the Board to adopt rules to clarify this purpose and to provide specifics to the general concept found in the Ohio Revised Code. One such section of the Ohio Revised Code permits the Board to waive specific qualifications for licensure if the applicant has passed an examination recognized by the Board.

This is further refined in Ohio Administrative Code (the rules that define how the law is administered) 4761-5-01: “For applicants for licensure by endorsement, the board recognizes the certified respiratory therapist examination (CRT) or the registered respiratory therapist examination (RRT) offered by the “National Board for Respiratory Care, Inc. (NBRC)...” In other words, to get a license in Ohio you must pass either the CRT or the RRT exam.

Recently the Board has begun to review the requirements for obtaining a license in Ohio. The Commission of Accreditation for Respiratory Care (CoARC), the national accrediting organization for respiratory care programs, has designated all respiratory care educational programs in Ohio, and nearly all the programs throughout the United States as a level 200 programs. These programs are referred to as Registered Respiratory Therapists programs. This designation requires them to prepare students to be eligible for the NBRC’s RRT examination.

The Board is considering an amendment to its current rule that would recognize the RRT examination as the minimum examination requirement to obtain a respiratory care professional license in the state of Ohio. This process will require the Board to consider all possible results of such a change. It is, in our opinion, a worthy undertaking in keeping with the Board’s mission. The Board has an obligation to the citizens of the state of Ohio to assure that professionals entering the practice are competent to provide safe and effective respiratory care services. We believe that NBRC RRT exam may be a better tool to determine ..”professional skills and judgment in the utilization of respiratory care techniques..”

To study this issue, the Board has held several meetings with managers and educators throughout Ohio in attendance. The response from these groups has been very supportive of the suggested change. Our process is now expanding to build a workgroup to study the matter. We’re also very interested in your opinion. ## “I did not receive a new license card in the mail” - Access to Online Verification

“I did not receive a new license card in the mail,” was a very common statement made to Board staff during licensing renewal this year. Prior notification to inform licensees that the Board would no longer print or mail new I.D. cards was included with renewal information mailed to each licensee. Some licensees missed the notice in their packet, some admitted they did not read it, some did not understand it and some disagreed with it and still want a new I.D. card. Thankfully, most of our licensees and limited permit holders read the information provided to them and understood that the Board was not issuing I.D. cards for FY 2010. It is a change that we knew might not be popular with some, but in general, we found that most licensees did not seem to mind the change and most employers welcomed the change. The Board’s decision to implement the new policy was based, in part, upon the experience of other Boards, such as the Ohio Board of Nursing, that had already instituted a no I.D. card policy. Other state agencies reported some growing pains during the transition.

Instead of issuing I.D. cards as proof of renewal, the Board directed licensees to the Board’s **License Verification** feature on the Board’s webpage: [www.respiratorycare.ohio.gov](http://www.respiratorycare.ohio.gov). The primary complaint we received was how to perform a license verification look up. If you are still trying, here is the procedure:

1. Go to [www.respiratorycare.ohio.gov](http://www.respiratorycare.ohio.gov).
2. Click on “License Verification” found under the title “**Information**” on the right hand side of the page.
3. Enter search criteria. **Use narrow search criteria.** You could enter only your last name, but your license number is the best search criteria. If using license number enter your credential type in the first box (RCP for licensees, L1 for students or L2 employment based limited permit holders). In the next box enter your license or permit number.

For example: License Number  .

4. Click “Search”
5. Click on your license number to access the full status record and to print for your records.

## Continuing Education Compliance

Continuing Education compliance was a big concern this year. In 2008, the Board amended the Ohio Administrative Code to require more continuing education hours. The new changes also included a provision that required one mandatory contact hour in profession/medical ethics or Ohio respiratory care law/rule review. Sometimes it is hard to know if all licensees actually receive, read and understand all of the new changes in the rules that govern the respiratory care practice. The Board is proud to report that random continuing education audits clearly indicate broad understanding of the new rules and significant compliance. All laws and rules governing respiratory care and home medical equipment licensure are available on the Board’s website: [www.respiratorycare.ohio.gov](http://www.respiratorycare.ohio.gov). That said, we believe the rules deserve repeating here so that licensees can review. Here’s the rule:

OAC4761-9-02 states, in part:

(1) An applicant for license renewal shall complete twenty contact hours of relevant RCCE every two years, beginning with the license renewal date and ending on the license expiration date established under division (D) of rule 4761-7-01 of the Administrative Code, unless the applicant meets a waiver provided for in rule. RCCE earned for license renewal must include the following content requirement:

(a) One contact hour of RCCE on Ohio respiratory care law or professional ethics as set forth in rule 4761-9-04 of the Administrative Code; and

(b) At least fifteen of the required contact hours must include content relating to the provision of clinical respiratory care as defined under section 4761.01 of the Revised Code; and

(c) The remaining four contact hours may include indirectly related content, including, but not limited to, activities rele-

want to specialized aspects of respiratory care, such as education, supervision, management, health care cost containment, cost management, health quality standards, disease prevention, health promotion, or abuse reporting.

(2) An applicant for renewal of a limited permit issued under division (A)(1)(c) of rule 4761-6-01 of the Administrative Code, shall complete ten contact hours of relevant RCCE every year, beginning with the limited permit renewal date and ending on the limited permit expiration date established under division (E) of rule 4761-7-01 of the Administrative Code, unless the applicant meets a waiver provided for in rule 4761-9-02 of the Administrative Code. RCCE earned for limited permit renewal must include the following content requirement:

(3) (a) One contact hour of RCCE on Ohio respiratory care law or professional ethics as set forth in rule 4761-9-04 of the Administrative Code; and

(b) At least seven of the required contact hours must include content relating to the provision of clinical respiratory care as defined under section [4761.01](#) of the Revised Code; and

(c) The remaining two contact hours may include indirectly related content, including, but not limited to activities relevant to specialized aspects of respiratory care, such as education, supervision, management, health care cost containment, cost management, health quality standards, disease prevention, health promotion, or abuse reporting.

#### **Waiver provisions:**

A first time license holder in the state of Ohio who has been licensed for more than six months, but less than one year from the license expiration date must complete at least ten contact hours of continuing education, including one contact hour on Ohio respiratory care law or professional ethics. First time license holders who have held a license for less than six months from the biennial license expiration date will not be required to complete the RCCE requirements for the current term of collection, but will have to complete the RCCE requirements for the next biennial renewal period.

A request to waive the RCCE requirements may also be filed and a waiver granted for either of the following:

(a) The applicant has been absent from Ohio for more than one half of the term of collection for the authorization type held due to military service;

(b) The applicant has been prevented from completing the RCCE requirement due to documented proof of a medical disability for more than one half of the term of collection for the authorization type held.

#### **Medical or Professional Ethics Courses:**

Of the hours required, the new rule states that one (1) contact hour must include education in medical or professional ethics or laws regulating the practice of respiratory care. **A recognized Ethics course must be approved by the Board and the certificate of completion issued to you should state so.** The Board has approved many continuing education courses that meet the medical or professional ethics requirement. These courses are generally individual course offerings. The Board; however, offers two (2) free one contact hour courses on its website. These courses cover Ohio laws or rules regulating the practice of respiratory care. The Board has contracted with **Quia.com** to offer these courses. Here's how it is done:

1. Go to the Quia website at <http://www.quia.com/web>. Select, "Student Zone." When the next page appears, click the button labeled, "Create my free account."
2. Select, "Student" as the account type.
3. Fill out the form that appears using first initial and last name as the user name. Quia will provide a password for your account.
4. When done, press the, "Create my account" button. (Write down the username and password for future reference. The Board does not collect password data.
5. After enrolled, type the QUIA class code provided on the Ohio Respiratory Care Board's course listing site that corresponds to the course to complete and push the "add class" button. When the class name, instructor name, and "Class page" appear you may view the class page to do the module. Click on the "[http://quia.com/pages/\[program title\]](http://quia.com/pages/[program title])" link next to the word "Class page."

# Home Medical Equipment Facility Continuing Education Requirements

---

The Board issues two distinctly different types of authorization to Home Medical Equipment facilities: a Certificate of Registration and a License. Licensed Home Medical Equipment facilities are required to comply with strict standards of practice that are established by the Board. The Board inspects Licensed facilities to gauge a facility's compliance with the standards. A Certificate of Registration holder is accredited by a nationally recognized organization and must adhere to the standards of their accrediting organization. Among the standards for licensed facilities is a requirement that licensees must provide continuing education to their staff. Here's the rule:

- (A) Each licensed HME facility must demonstrate that a continuing education plan has been developed that provides continuing education for staff rendering HME services to the public in the state of Ohio.
- (B) The qualifying continuing education program must meet or exceed the following guidelines:
  - (1) Staff must complete no less than ten contact hours of continuing education per renewal cycle. Of the required hours:
    - (a) No more than five contact hours may be non-accredited in-service education;
    - (b) The remaining hours must come from educational programs specific to the type and level of HME service provided that are approved by an organization recognized by the Ohio respiratory care board that provides education relating to home medical equipment services or specific clinical affiliation; and
    - (c) Clinical and equipment cleaning/maintenance staff must have one contact hour of continuing education on infection control, equipment cleaning and cleaning agents, rotation of inventory and equipment separation.
- (C) Continuing education credits shall be documented for employed staff involved in HME service delivery to the public. Records of attendance and completion shall include:
  - (1) Sign in logs; and
  - (2) Agendas and training manuals for facility based in-services;
  - (3) Documentation of completed continuing education courses taken by each staff member must be maintained in that employees personnel file and must be available for review by a board investigator upon demand.
- (D) Any organization that provides HME continuing education may apply to the board to be recognized as an authorized continuing education provider. Request for recognition must be made in writing to the board and the organization must provide the board with an overview of their agency and an outline of the continuing education courses provided by that agency, including course content.

Compliance includes:

1. Establishing a continuing education plan (4761:1-13-01 (A) OAC)
2. Staff must complete no less than ten contact hours of education (4761:1-13-01 (B) OAC), which must include:
  - No more than five non-accredited in-service hours (these are internal training that must be documented)
  - At least five hours of education from a recognized provider. A list of approved providers is available on the Board's website: [www.respiratorycare.ohio.gov](http://www.respiratorycare.ohio.gov).
  - One hour must include education on infection control, equipment cleaning and cleaning agents, rotation of inventory and equipment separation

## 2011 Limited Permit Renewal

---

2011 Limited Permit Renewal applications will be mailed on March 15, 2011. **It is very important that you provide the office with changes to your name or address information.** The Board issues two different limited permits: one is issued to student or program graduates and the other is issued to persons employed in the practice prior to March 13, 1990. Student permit holders (designated as L1-STU permits) are eligible for renewal if they are still enrolled in and in good standing in an accredited respiratory care program and have not held the permit for more than three years. A graduate therapist (designated as L1-GRAD permits) is only eligible if no more than one year has lapsed since the date of graduation on the expiration date of the limited permit. Employment based limited permits (designated as L1-EMPL or L2-EMPL permits) are eligible for renewal if they are employed as a provider of respiratory care and have completed ten (10) contact hours of continuing education, including one hour of ethics or law/rule review.

## Board Membership Changes



Darrell L. Heckman, J.D. resigned from the Ohio Respiratory Care Board on September 30, 2010. Mr. Heckman served as the Board's public member from August 13, 2008 until his resignation. Previously, Mr. Heckman had served on the Board for an additional six-year term. Mr. Heckman returned to his private law practice in Urbana, Ohio.



Sandra Stabile Harwood, J.D. was appointed to serve on the Ohio Respiratory Care Board on January 3, 2011 by Governor, Ted Strickland. As the Public Member of the Board, Ms. Harwood is tasked with representing the interests of the general public on matters of policy and administrative matters. Business Administration and later earned her law degree from the University of Akron. She served eight years as a State Representative from Ohio's 65th district, residing in Niles, Ohio. Ms. Harwood has a passion for children and has advocated and supported legislation to improve health insurance costs in child support orders and fought for regulations for child and youth care workers.

## Medicare Implements Competitive Bidding Program for Durable Medical Equipment



The Medicare DMEPOS Competitive Bidding program was enacted under the Medicare Prescription Drug Improvement and Modernization Act of 2003. Under the provisions of the federal regulations, DME providers are required to bid on Medicare contracts that cover a broad range of DME items (eg. Oxygen concentrators, CPAP devices, hospital beds, wheelchairs, scooters, enteral supplies, etc.). According to the Center Medicare/Medicaid Services (CMS) contract suppliers must agree to accept assignment on all claims for bid items and will be paid the bid price amount. The price is derived from the median of all winning bids for an item.

The program was briefly implemented in ten metropolitan statistical areas (MSAs) in 2008, but terminated shortly after Medicare announced bid winners. In 2009, the program reopened the round one bid process for the original ten MSAs, which includes Cleveland and Cincinnati.

The contract bidding program will be expanded in 2011 (round two) to include 91 additional MSAs. According to the Center Medicare/Medicaid Services the bid evaluation process ensures that there will be a sufficient number of suppliers, including small suppliers, to meet the needs of the beneficiaries living in the competitive bidding areas.

### The Commission on Accreditation for Respiratory Care Announced Withhold of Accreditation for Miami-Jacobs Career College

The Commission on Accreditation for Respiratory Care announced a decision to withhold accreditation for the Miami-Jacobs Respiratory Care program effective September 7, 2010.
