



ORCB Files Rule Proposing to Require the RRT Credential for Initial Licensure by 2015

On December 7, 2011, I reported that the Ohio Respiratory Care Board (“the Board”) passed a motion to begin drafting a new rule that would lead to requiring passage of the Registered Respiratory Therapist (RRT) examination offered by the National Board for Respiratory Care, Inc. (NBRC) to obtain a license in the state of Ohio. After more than two years of studying this proposal, meeting with stakeholders, and drafting rules, the Board filed a series of proposed rules on January 7, 2013 with the Joint Commission of Agency Rule Review (JCARR) to require the RRT examination for initial licensure in Ohio, beginning in 2015. Before explaining this process further, I need to state that this proposal would have no impact on persons currently licensed in the State of Ohio or persons currently licensed in other states prior to the full implementation date in January 2015.

The proposed rules essentially align the core goals and objectives of accredited respiratory care education with the competencies that programs are intended to achieve by preparing graduates to practice as RRTs. This proposal, while not supported by the NBRC and a few individuals, was supported by the majority of stakeholders involved in this process. Further, surveys conducted by the rules drafting group found that trends in Ohio seem to support a move toward higher competency expectations at the point of graduation as verified by the RRT credential. Nationally, similar surveys also seem to support this expectation by 2015. Having decided to move forward with filing this rule, the Board understands that doing so is somewhat controversial and Ohio would be the first state to consider such an initiative. However, the Board is resolved that these rules are necessary to assure greater consistency in the competency expectations of our future graduates from respiratory care educational programs.

The last step in making the rule change final is the filing of the rules with the Joint Committee on Agency Rule Review (JCARR), a joint committee of members from the Ohio House of Representatives and the Ohio Senate. This esteemed committee is charged with validating that the Board has the authority to adopt the rules and that the Board is not exceeding the legislative intent of its mandate. Filing a rule with JCARR requires the Board to hold a public hearing. A public hearing is intended to elicit proponent and opponent comments and recommendations concerning the proposed rules. After considering information gathered during the public hearing, the Board may choose to withdraw the proposed rule(s), amend the proposed rule(s), or leave the proposed rule(s) unchanged. After the Board’s hearing, the proposed rules are reviewed by JCARR during an open hearing. JCARR may reject the rules or allow the rules to be final filed. JCARR may also informally make recommendations on the rules.

Summary of Proposed Administrative Rule

The following rules have been filed with the Joint Committee on Agency Rule Review (JCARR), but not adopted:

Respiratory Care Licensing ORC 4761 rules proposed:

Rescind 4761-5-01: Recognized examinations.

Summary: The Board proposes to rescind this rule and replace it with a new rule 4761-5-01 titled, “Waiver of licensing requirements pursuant to division (B) of section 4761.04 of the Revised Code”.

New rule 4761-5-01: Waiver of licensing requirements pursuant to division (B) of section 4761.04 of the Revised Code.

Summary: The Board proposes to create a new rule that replaces current rule 4761-5-01. The new rule amplifies paragraph (B) of section 4761.04 of the Revised Code for persons seeking **first-time licensure** in Ohio. This section authorizes the Board to waive the requirements for licensure for persons licensed in other states whose standards for licensure are equivalent to those in Ohio on the date of application or waive the education and examination requirements for licensure for an applicant that presents proof of completing any examination recognized by the Board.

Prior to January 1, 2015, the new rule proposes to recognize the Certified Respiratory Therapist (CRT) examination offered by the National Board for Respiratory Care, Inc. (NBRC) as meeting the education and examination waiver requirements for licensure. After January 1, 2015, the new rule proposes to recognize only the RRT examination offered by the NBRC as meeting the education and examination waiver requirements for licensure. Recognized examinations must be passed within three years of the date of application. In addition, prior to January 1, 2015, the proposed rule will waive Ohio licensure requirements for persons holding an active, valid license in another state(s) based in part or in whole upon successfully completing either the CRT or RRT examination. After January 1, 2015, the proposed rule will waive Ohio licensure requirements for persons holding an active, valid license in another state or states based in part or in whole upon successfully completing only the RRT examination. Specific waiver language of the three-year examination recognition period is added for persons working for the federal government.

The proposed rule also includes language addressing persons that have taken and passed the Ohio credentialing examination pursuant to rule 4761-5-02 of the Administrative Code or are licensed in another state under equivalent standards.

Amended rule 4761-5-04: License application procedure.

Summary: The Board proposes to amend the existing rule by deleting the requirement for filing an official final transcript. The proposed amendment inserts language requiring a person licensed in another state or states to provide verification of licensure in the form of a letter or electronic verification via a secure validation

process. The verification letter must include name of the state, name of the licensee, initial issuance date, current status, expiration date and the examination upon which the license was issued. The rule also proposes to require persons from another state that are seeking Ohio licensure to document the number of contact hours of continuing education required by the state(s) of origin. For persons seeking Ohio licensure, applicants must provide verification of successful completion of any examination recognized by the Board. The proposed rule also includes new language authorizing the Board to use regular mail as record of service for incomplete notification, if the original notification is returned as “unclaimed” by the postal service. Last, the rule proposes to delete paragraph (D) of the current rule that addresses the waiver of the education component for licensure.

Amended rule **4761-8-01: Renewal of licenses or permits.**

Summary: The Board proposes to amend the existing rule by adding language to paragraph (G) (2) of the current rule requesting a letter of license verification from other states, if the Ohio license is lapsed or inactive for less than three years. New language is added that allows the Board to consider the number of hours of continuing education required by another state and, if needed, require an applicant to complete more continuing education if the standards are not equivalent to Ohio standards. The proposed rule corrects a reference to paragraph (K) and inserts new language addressing incomplete notification and abandonment procedures for incomplete license and limited permit reinstatement applications.

Home Medical Equipment Services ORC 4752 rules proposed:

Amended rule **4761-1-10-03: Licensees and certificate holders must comply with investigations conducted by the board.**

Summary: The Board proposes to amend the existing rule. The Board proposes to insert language clarifying that the rule is for licensed HME providers and certificate of registration holders. The rule adds new language for facilities holding a certificate of registration, stating that the facility may be investigated in accordance with the cooperative agreement entered into between the Board and the accrediting organization. The registrant must make records available to the Board’s investigator and upon request of the Board or its investigative staff produce copies of records. The rule also adds new language for facilities holding a license, stating that the facility may inspect or investigate the licensed facility. The licensee must make records available to the Board’s investigator and upon request of the Board or its investigative staff produce copies of records. Non-compliance with an investigation is grounds for disciplinary action pursuant to division (A) of section 4752.09 of the Revised Code.

License Renewal—2012

In FY 2012, the Ohio Respiratory Care Board achieved a 96% participation rate in online renewal applications for respiratory care professionals. In addition, the Ohio Respiratory Care Board also implemented online renewal for HME service providers, achieving a 50% participation rate with the online process. Each renewal, the board staff reviews the prior period’s process and implements changes to improve the flow and ease of use of the online system. Since its inception in 2004, online renewal has become the preferred method of license renewal. As of June 30, 2012, 7,357 persons in Ohio held an active license to practice respiratory care. Active respiratory care licenses held continues to trend higher each biennium, ranking the state of Ohio the fourth largest state in the U.S. in terms of licensed therapist, behind California, Texas and Florida.

As of June 30, 2012, 77 home medical equipment facilities held active licenses and 767 home medical equipment facilities held active certificates of registration, giving Ohio an active total of 844 licensed or registered

2013 Limited Permit Renewal

It will soon be time to renew limited permits. Limited Permit renewal is an annual requirement under the Ohio Revised Code. Renewal applications are generally mailed to renewal candidates on or after March 15th of each year. Limited Permits are issued to three groups and renewal requirements for each group vary. In addition to meeting core renewal requirements, other factors may limit a person's qualification for renewal. Limited permits issued to students and/or graduates of a respiratory care program are only valid until one of the following conditions is met:

1. Three years after the date the limited permit is issued;
2. One year following the date of receipt of a certificate of completion from a board-approved respiratory care education program; or
3. Until the holder discontinues participation in the educational program.

If a limited permit issued to a student or graduate of a respiratory care program meets any of the three conditions above, state law dictates that they are ineligible for continued practice.

In addition, if a person holding a limited issued on the basis of qualifying employment history (often referred to as "L2" permits), is no longer employed then state law dictates that the permit cannot be renewed.

American Academy of Sleep Medicine Proposal Rejected by OIG

AAHomecare reported that the U.S. Department of Health and Human Services, Office of Inspector General (OIG) rejected a proposal by the American Academy of Sleep Medicine (AASM) to allow physicians certified by the American Board of Sleep Medicine to conduct sleep testing and provide CPAP equipment to Medicare beneficiaries. The opinion of the OIG was released in its semi-annual report to the congress.

The AASM proposal sought relief from the Federal Anti-kickback law, known as the Stark Law. In its opinion, the OIG stated that adding a new exception or waiver to the Stark Law was beyond the authority of the OIG. In addition, AA-Homecare reports that the OIG opined that the AASM's proposal is subject to abuse and should be evaluated on a case-by-case basis.

The AASM states that the current system that requires a patient to interact with an outside home medical equipment provider to obtain CPAP equipment "adds an unnecessary layer of complexity to the treatment plan for Medicare patients." The AASM states that board certified sleep medicine physicians are uniquely qualified to treat patients with obstructive sleep apnea and that allowing certified sleep medicine physicians to provide the equipment improves the continuity of care that will lead to treatment success and long-term compliance with therapy.

home medical equipment facilities providing services to Ohio citizens. More HME facilities now seek accreditation to meet the CMS participation standards. This has led to a significant upward trend in the issuance of Certificate of Registrations and a downward trend in licensed facilities.

Andrea D. Yagodich, BS, RRT, RCP was appointed to the Board on January 29, 2013. Ms. Yagodich is replacing Mr. Pettinichi and will serve the final year of his term, ending March 14, 2014. Ms. Yagodich is employed as the Respiratory Therapy Education Team Leader for the Wexner Medical Center at the Ohio State University. Ms. Yagodich has served in this position since 2003 and is well known for her coordination of the annual Current Concepts Conference sponsored by the Ohio State University.

Board considers changes to RCCE reporting requirement

The Ohio Respiratory Care Board met during regular session on December 12, 2012 and considered a revised 2014 renewal form for respiratory care professional licensure. After considerable debate, the Board moved to revise the 2014 license renewal form. The new form will eliminate the documentation requirement for completed continuing education. In its place, the form will only ask if you have complied with the laws and rules by completing all 20 contact hours of continuing education. The same change will be made to the on-line license renewal process.

Continuing education documentation during renewal is the number one complaint we receive from licensees. Failure to enter information into the online system or on the paper form is also the Board's number one correction notification mailed each renewal. By eliminating this requirement, licensees will save time performing online renewal filing. In addition, the Board will improve response time by reducing review time on each application.

To adjust for this change, the Board is considering increasing the number of audited licensees. This means maintaining accurate records and knowing the laws and rules is critical. Licensees must be even more vigilant at maintaining their documentation, not losing or destroying records and knowing what education qualifies as recognized education. Here's some tips:

1. Unless a licensee meets a waiver under [OAC 4761-9-02](#) (G), the Board requires licensees to complete 20 contact hours of **recognized** continuing education (see [OAC 4761-9-05](#)) every renewal cycle. 15 contact hours must be directly related to the provision of clinical respiratory care, up to 4 contact hours can be indirectly related, and 1 contact hour must be an **approved** hour on professional/medical ethics or Ohio respiratory care regulation law review (see [OAC 4761-9-04](#)).
2. If a continuing education course is taken before the rule allows or before the licensee is actually licensed, it is not accepted by the Board.
3. Know what activities are not accepted (see [OAC 4761-9-03](#)). For example: Personal development activities not taken for the purpose of meeting RCCE requirements would not be recognized. This could include academic education taken for another profession degree, such as nursing.
4. A licensee is responsible for maintaining all documentation that supports compliance with OAC 4761-9. Documentation must be kept for two renewal cycles (four years for license holders).
